LUMP SUM PACKAGE DETAILS

LUMP SUM training package for a SHOVEL or Heavy Tractor Vehicle includes UNLIMITED classes of initial driving assessment training or signal training and second driving assessment training or preliminary training and final driving assessment or road training.

- Training Clause : Unlimited classes applies only during the active validity period of the package and is subject to instructor and vehicle availability, scheduling, and operational capacity.
- Test Attempts Policy : The Trainee is entitled to a maximum of THREE (3) attempts for the Signal Test, THREE (3) attempts for the Preliminary Test, and up to NINE (9) attempts for the Road Test. All test bookings, including any reduced or priority test dates, are strictly subject to the availability, scheduling, and final approval of the relevant MOI or Traffic Department, and may vary depending on official regulations and capacity at the time of booking.
- Failure After Allowable Attempts : If the Trainee fails beyond the included number of test attempts, additional test fees or charges will apply as per the prevailing rates , see standard rates packages rates.
- Reduced Dates Policy: Includes a maximum of FIVE (5) reduced test dates only ; any reduced, postponed, or rescheduled test dates requested beyond the allowed FIVE (5) will be subject to additional charges as per the school's standard package rates and Traffic Department availability.

- Policy Update : IDI reserves the right to amend these terms and conditions without prior notice, in compliance with UAE and MOI regulations.
- Offer Packages , Discounts or Prices may change without prior notice.

Document Needed / Requirement

1. ACCESS TO UAE PASS IS NEEDED.
2. MEDICAL REPORT IS VALID ONLY FOR 90 DAYS FROM THE ISSUANCE DATE (QR CODED MANDATORY)
3. for UAQ Visa Holders
 - Valid Emirates ID (original + copy)
 - Valid Passport Copy
 - Eye Test Result from MOI-authorized optical centers
 - Passport-size Photo (studio photo + hard copy)
4. for NON-UAQ Visa Holders
 - Valid Emirates ID (original + copy)
 - Valid Passport Copy
 - Eye Test Result from MOI-authorized optical centers
 - Passport-size Photo (studio photo + hard copy)
 - Company's Trade License copy – (UAQ Branch & as per Visa Residency, under the same sponsor's name).
 - NOC from Sponsor in UAQ Branch & as per Visa Residency—(mentioning you are working and living in UAQ. NOC must be stamped & signed, mentioning the required category i.e motorbike, light vehicle, heavy vehicle, etc.). **OR**
 - Tenancy Contract (Umm Al Quwain residence) with valid link.

Terms & Condition

- **Minimum Age to Register:** 20 years old.
- **Arrival Time and Proper Decorum or Attire :** Trainee must arrive 15 minutes prior to the scheduled test. Please wear respectful clothing.
No shorts or revealing clothes allowed in office or test.
No sunglasses during training or test.
No headphones or smart watches allowed during tests
- **Rescheduling Policy:** Rescheduling must be done at least 48 hours in advance.
- **Absences:** The Trainee will be subject to additional charges if they are absent or arrives late for any of the training classes, initial assessment and tests.
- **Test Failure or Re-Test:** If the Trainee fail on any PRELIMINARY or road test, it is mandatory to take MINIMUM 4 CLASSES of practical classes before retaking the PRELIMINARY or road test. Additional charges apply for any test attempts beyond the permitted attempts.
- **Learning Permit :** The Trainee has to pay for Learning Permit and file renewal charges , that is AED 238.00 every six (6) months.
- **Medical & Eligibility Responsibility :** The Trainee is responsible for meeting all medical, legal, and eligibility requirements set by the UAE Traffic Authorities.
- **VAT:** VAT is applicable on total package fee.
- **Document Authenticity and Liability:** Any submitted documents are the responsibility of the Trainee.
